Declaration on handling of personal data in accordance with the GDPR

hereby declares,

that as an entity handling the personal data of natural persons within the framework of his activities, he is familiar, to the extent necessary for his commercial activities, with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)

and hereby undertakes

to apply this regulation in practice within the framework of the applicable legislation.

The Operator does not process the personal and other data of the users of the website of the Černý kůň guesthouse other than for the purposes permitted by law – enquiries regarding accommodation, or for purposes which the user has voluntarily agreed to – confirmed in writing.

The website of the Černý kůň guesthouse does not have any database of users, their email addresses, or an offer distribution system, i.e. it does not collect any personal data of users.

The enquiry form, which records personal data (name, phone number and email address) is sent to our email address penzion.kun@seznam.cz, where a response is then provided for the purpose of concluding a contract, booking accommodation. If no order is placed, the personal data will be deleted from the email immediately, because the one-off purpose (enquiry and reply) of handling personal data has been fulfilled. If a contract is concluded, we then follow the applicable laws of the Czech Republic relating to records of contracts and invoices.

Personal data which is processed

- In relation to citizens of the Czech Republic, the Operator, in his capacity as an accommodation provider, in particular processes those items of personal data which he is obliged to record pursuant to Act No. 565/1990 Coll. of the Czech National Council, on local fees, as amended (hereinafter referred to also only as "ALF"), i.e. duration of accommodation, purpose of stay, name, surname, permanent residence address or permanent residence address abroad and number of personal ID card or travel document of the hotel Guest.
- In relation to foreign nationals, the Operator, in his capacity as an accommodation provider, in particular processes those items of personal data which he is obliged to record pursuant to Act No. 326/1999 Coll., on the residence of foreign nationals in the Czech Republic and on amendment of certain Acts, as amended (hereinafter referred to as the "ARFN"), i.e. the name and surname of the Guest, their date, month and year of birth, nationality, permanent residence address, travel document number and visa number (if indicated on the travel document), start and end of accommodation, place of stay and its expected duration, and purpose of stay.

Period of processing of personal data

- In his capacity as an accommodation provider, the Operator is obliged to record personal data relating to citizens of the Czech Republic in the respective guest register and personal data relating to foreign nationals in the respective accommodation register. Personal data of Czech citizens and foreign nationals are therefore usually processed by the Operator for the period of retention of the respective guest register or accommodation register, unless the Operator needs to process them for any reason for a longer period of time (in particular to protect his legitimate interests consisting in establishing, exercising or defending legal claims and exercising, protecting or defending the rights of the accommodation provider or to meet other obligations determined by law). The Operator is legally obliged to keep the guest register and the accommodation register for 6 years from the date of the last entry.

Personal data (or certain items of such data) processed by the Operator may be disclosed to a third party belonging to one of the following groups:

- employees of the Operator and persons performing work for the Operator under an alternative employment relationship
- persons performing bookkeeping for the Operator and handling matters related to this for him
- persons providing legal services to the Operator
- public authorities (which are designated or authorised under the relevant legislation to handle the recorded personal data of citizens of the Czech Republic or foreigners and/or to check compliance on the part of the accommodation provider with the obligations set out in the ALF and ARFN or other legislation, as well as in meeting of the legal obligations of the Operator or in establishing, exercising or defending legal claims and exercising or defending the rights of the Operator), unless the public authority is not considered to be a recipient of personal data under the GDPR
